What is the overall deductible ?	\$500 individual medical combined Network and Out-of-Network \$1,000 family medical combined Network and Out-of-Network	Generally, you must pay all the costs up to the deductible amount before this plan begins to pay.
Are there services covered before you meet your deductible ?	Yes. Well-child care, prenatal care and Network Preventive care services are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan?	\$750 individual medical combined Network and Out-of-Network \$1,500 family medical combined Network and Out-of-Network \$300 individual drug combined Network and Out-of-Network \$500 family drug combined Network and Out-of-Network	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.

What is not included in the out-of-pocket limit ?	Premiums , balance-billed charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

This plan uses a provider network . You will pay less if you use a provider in the plan's network . If you don't have [Minimum Essential Coverage](#) for a month, you'll have to make a payment when you file your tax return unless you qualify for an exemption from the requirement that you have health coverage for that month.

Does this Coverage Meet the Minimum Value Standard? Yes.

If your [plan](#) doesn't meet the [Minimum Value Standards](#), you may be eligible for a [premium tax credit](#) to help you pay for a [plan](#) through MNsure/the Marketplace.
